Service Charges for Original Project, Benscreek Project and Woodmont Area

Metered Service

All Customers Connected

Quarterly Charge

\$93.84 First 10,000 Gallons

\$12.51 Per Thousand after 10,000 Gallons

(REVISED 4/16/2018 – Effective 5/1/2018)

Services for Unmetered Customers

All unmetered customers charged same minimum rate as the metered customers of the same area.

Original Project \$93.84 Quarterly Charge or \$31.28 Per Month

Benscreek Project \$93.84 Quarterly Charge or \$31.28 Per Month

Woodmont Project \$93.84 Quarterly Charge or \$31.28 Per Month

Late Charges

Late Charges are 5% on any balance due.

Non-Compliance Fees

1-12 months violation: \$150 per quarterly billing or \$50 per month

13-24 months violation: \$225 per quarterly billing or \$75 per month

25 months and beyond violation: \$300 per quarterly billing or \$100 per month

Treatment Charges

(As imposed by the Johnstown Redevelopment Authority, or successor)

Unmetered Service

“Any customers not having metered water service will pay the quarterly minimum charge effective in their area until such time as meters are installed.”

Connection Charges

Taps – Revised by formal motion during the June 20, 2005, Upper Yoder Township Authority regularly scheduled monthly meeting.

Connection Fee in all service areas will be based upon actual tap cost incurred by the Authority with a minimum Connection Fee of \$1,200.00, and a maximum Connection Fee of the actual cost. A Tap Fee has been instituted for all service areas for the privilege of connecting to the Authority's sewer lines. The Tap Fee has been set at \$1,200.00. The inspection fee is \$50.00. Resolution No. 6-20-05-1

An inspection fee of \$50.00 will be charged on all taps that are made into private lines that eventually go into the Upper Yoder sewers. Inspection fees must be paid before building permits are issued. All work must be inspected by the Authority before same is covered over.
